**INCOME GUIDELINES FOR EXEMPTION TO CITY OF MILL VALLEY  
2025-26 LIBRARY TAX**

February 3, 2025

Dear Property Owner,

The following are the **Income Guidelines for Exemption to City of Mill Valley 2025-26 Library Tax:**

1. The property must be owner occupied.
2. The total **gross household income** from all sources, including social security, for the 2024 calendar year does not exceed the following:

For a single-person household:	\$130,600
For a two-person household:	\$149,300
For a three-person household:	\$167,950
For a four-person household:	\$186,600
For a five-person household:	\$201,550
3. In order to meet the deadline to qualify for the exemption on your September, 2025-26 tax bill, **you must file your request by May 31, 2025.**
4. **You must reapply each year** to keep the exemption in effect. A form will automatically be sent to those who filed the previous year.

If you qualify, please complete and sign the **Declaration of Exemption to City of Mill Valley 2025-26 Library Tax Form** on the reverse side of this page.
