INSTRUCTIONS

1. This parcel tax exemption is for property owners who are over 65 years of age or older by July 1, 2026.
2. This parcel tax exemption is for your principal place of residence only and applies to one parcel only.
3. You will need to apply annually for the Measure R senior exemption.
4. To find your Parcel Number, look for the 8-digit number (XXX-XXX-XX) on your property tax bill, or call the Marin County Assessor at (415) 473-7215.
