

## Low-Income Exemption Application

### Belvedere-Tiburon Library Agency Community Facilities District No. 1995-1 - \$66 Special Tax

*This application serves as a request for a CFD No. 1995-1 low-income exemption.*

**(CFD No. 1995-1)** - To qualify for a low-income exemption for the \$66 CFD No. 1995-1 special tax for a single family residence, you must own and occupy your residence located within the City of Belvedere or the Town of Tiburon, and earn a total annual household income\* of not more than **\$109,700** (HUD Low-Income limit for Marin County residents).

**This application must be filed on or before June 1, 2025, for the 2025/26 tax year.** Failure to file on time will result in rejection of your application unless good cause can be shown for failure for a timely file. If approved, the low-income exemption will only apply for one year. You must file a new low-income exemption form for each year in which the CFD No. 1995-1 special tax is in effect.
